### SHAVINGS PROCEDURE

Pre-order your shavings by calling Randi Preiser, (520) 240-0124 for advanced deliver. When filling out your entry form include the number of bags of shavings ordered. Shavings cost \$12 per bag. Post Entries will order shavings in the Show Office upon arrival. You may also purchase feed through the Show Office. The Fairgrounds does not allow outside shavings. No straw is allowed on the grounds.

### GENERAL INFORMATION AND RULES OF THE SHOW

**<u>ADMISSION TO THE RING</u>**: No person shall be permitted to enter the ring except participants in the class, judge, their assistants and show officials. Attendants and grooms may enter the ring only when summoned by order of the judge. In all classes requiring attendants in the ring, proper attire is required.

**<u>AHA VALUE SHOW</u>**: This show is recognized by the Arabian Horse Association (AHA). AHA Value Shows only count toward AHA qualifications and programs. This show qualifies for Regional, Youth, S port Horse, Canadian & US Nationals.

### TBA (To Be Announced) Classes

Any class on the AHA Class List or that is recognized by AHA is eligible to be added to this show as a TBA class with the following exception: Arabian & HA/AA all over fence classes; all cattle classes; Dressage, Western Dressage, Sport Horse In-Hand & Under Saddle, Driving classes and Ranch Horse classes by special approval of Show Management.

TBA classes are offered on a first request basis and must be accompanied with a \$30.00 sponsorship for each performance class and a \$35.00 sponsorship for each championship class.

TBA classes will be announced prior to the beginning of the show and posted in the show office and on the SAAHA FaceBook page as added. No post entry penalty to enter TBA classes but normal class fees do apply for everyone. If these classes are not filled, the class number will be canceled and the next class will begin immediately.

Please contact the Show Secretary if you would like to sponsor a TBA class. Show Management reserves the right to change the designation of a TBA class in the interest of the flow of the show schedule.

### AHA MEMBERSHIP STATEMENT:

- EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR.
- WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP.
- SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS.
- EXHIBITORS IN WALK-TROT 10 & UNDER CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS.
- EXHIBITITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

<u>AMATEUR OWNER/JUNIOR OWNER TO RIDE CLASSES</u>: An owner's class is one in which every contestant is a Junior/Amateur and the rider/handler is the owner or Amateur/Junior member of the owner's family. Unrelated owners in owner classes are now allowed. Refer to USEF AR110.4.e. for complete requirements and limitations. Leased horses are not eligible (contracts of Sale or Bill of Sale will not be accepted in owner classes).

**<u>ARENAS</u>**: MAIN BARN ARENA is indoors; 117ft x 250ft; footing is topsoil & sand mix over natural base. RAMADA ARENA is an open air, covered arena; 116ft x 200ft; footing is topsoil & sand mix over natural base. NORTH ARENAS are outside; 275ft x 150ft; topsoil & sand mix over natural base. SOUTH ARENAS, Ring 1 & 4, are outside arenas; footing is sand on a crushed marble base. Lunging is not allowed in any of the show or warm-up arenas. Lunging locations are in an arena on the north side of the barn.

### **<u>RIBBONS</u>** (all classes)

- Open/Amateur 1st through 6th
- Junior 1<sup>st</sup> through 8<sup>th</sup>

**BIKES & MOTORIZED VEHICLES:** Minors must wear safety helmets when riding bicycles per AZ State Law. In accordance with USEF GR 901.29: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including, but not limited to segways, hover boards

and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signed the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**BARN RULES:** NO SMOKING IN THE BARN AREA. Only manure to be placed in areas designated, violators caught placing anything other than manure and shavings in designated areas will be fined according to USEF rules. Do not modify stalls without prior approval of the Pima County Maintenance Staff. Stalls must be vacated in their original condition. Exhibitors will be financially responsible for damage to their stalls and/or labor cost for remoting materials used for stall decorative purposes.

**<u>CHAMPIONSHIP QUALIFYING CLASSES</u>**: To enter a championship class you must have entered, shown and been judged in the qualifying class. Qualifying classes are listed in the Class Details.

**<u>CLASS CALLS</u>**: Due to unforeseeable problems with any mechanical device, the PA system, paddock and barn calls must be considered a courtesy. It is the responsibility of the exhibitor to be sure their horse is at the gate at the prescribed time. Every effort will be made to maintain a working PA system to carry class calls; however, no protest will be upheld, nor will any class be changed on the basis of PA malfunction alone.

**<u>COMMERCIAL VENDORS</u>**: Fees are \$50 per day. Set up may begin on Friday, January 10, 2025 and must be removed no later than Monday, January 13, 2025. Security is the vendor's responsibility; SAAHA will not be responsible for merchandise left on the grounds. Space location will be determined by show management, contact Randi Preiser (520) 240-0124 to make reservations.

**DOGS:** Pima County and the Southwest Fair Commission require dogs to be on a leash at all times. Loose dogs may be detained by Fairground personnel and owners charged a fine. Owners are also expected to clean-up after dogs; supplies are provided throughout the Fairgrounds.

**DISCIPLINE:** Exhibitors are warned that any act of discourtesy or disobedience to the officials of this show on the part of the owner, exhibitor, agent, trainer, groom, rider, handler or family of the above, will disqualify the horse from adjudication. The management reserves the right to remove a horse, owner exhibitor, agent, trainer, groom, rider or handler from the show without being liable for compensation or damage.

Any action(s) against a horse by an exhibitor, which are deemed excessive by a judge, USEF Steward or show veterinarian in the show ring or anywhere on the competition grounds may be punished by official warning, elimination or other sanctions which may be deemed appropriate by the Show Commission. Such action(s) could include, but are not limited to, excessive use of whips, spurs or bamboo poles.

**DRUGS & MEDICATIONS:** The drugs and medication rules contained in the current USEF rulebook will be enforced.

**FARRIER**: A farrier will be on the grounds during show hours. Emergency numbers will be posted.

HALTER: If we have Halter TBA classes added we will use the comparative judging system for all Breeding, In-Hand classes; in Ring procedure will be followed. Performance Halter will use the AHA score sheet.

**HORSES NOT COMPETING:** Horses brought to the show grounds but not entered in the show must pay the appropriate stall or grounds fees and the \$50.00 office fee. They are also required to have proof of vaccinations. **No exceptions.** 

**ENTRIES**: Entries must be submitted on the official entry form for this show (photocopies – both sides required – are accepted). Please type or print legibly Additional forms can be requested from the show secretary or downloaded from <u>www.SouthernAZaha.com</u>. (Note new website address)

All horses belonging to one owner must be on one entry form (additional entry sheets may be attached). No horse may be entered on more than one entry form. The complete name and address of the registered owner must appear in the "Owner" space. If a farm name is used as "Owner," the farm must have an AHA Farm/Ranch membership farm certificate, be listed as the owner on the horse's registration papers and that Farm/Ranch membership number must be used as the Owner AHA number. A copy of the Farm/Ranch membership card must accompany the entry

Owner (or agent), trainer and all riders/handlers must sign entry form (adult signatures only) in the spaces provided and provide addresses, telephone numbers where requested. If the owner is the trainer, owner must sign on both owner and trainer spaces. (Trainer is "any adult who has the responsibility for the care, training, custody or performance of a horse.")

Junior exhibitor's name, address and birth date must appear on the entry form along with parent's/guardians signature in the appropriate area on the back of the entry form for each junior exhibiting in the show.

After completing the entry form, mail it, together with the following, to the address below:

- 1. A check (not posted dated) or credit card for all fees and charges (Visa, Mastercard, American Express or Discover)
- 2. A copy of both sides of the registration papers for ALL horses entered

3. A copy of all AHA Competition membership cards for the owner, trainer and all exhibitors (does not apply to Open Breed Entries)

4. The AHA Farm/Ranch membership for farm owned horses.

**<u>COPIES OF AHA COMPETITION CARDS</u>**: Owners, Trainers, Handlers and Riders must provide a copy of their current AHA Competition cards with their entry forms or pay AHA Single Event Fee or if applicable. Does not apply to Open Breed entries.

# Make all checks payable to SAAHA. Entries close December 30, 2024; post entries are accepted in all classes. Every perfect entry receives a thank you gift. If your perfect entry is submitted by the close of entries you will be entered into a drawing for a free stall.

All fees must be paid in full, by cash, credit card, cashier's check or money order before packets will be released in the show office. There will be a 5% service fee added when using a credit card.

Total entry fees, groom/tack room fees and other applicable fees must accompany each entry by check, money order, Visa, MasterCard, or Discover card. Postdated checks will not be accepted. Open checks submitted with entries will be totaled and closed when the entry is processed. Entries received without payment will not be processed until payment is received and will be subject to post entry penalties if payment is postmarked after close of entries. All horses brought onto the grounds must have a completed entry form and be issued a number whether competing or not. If entries are mailed close to or on the closing date the envelope must be hand-cancelled by US Postal Service.

**IDENTIFICATION NUMBER** (Back Numbers): Every horse entered in the show will be assigned an identification number. It is important for the proper handling of the show that correct numbers be worn by the riders and handlers in all classes.

### SHOW RULES, VIOLATIONS AND PENALTIES (BOD 8/02)

1. Membership, registration and other rule violations will subject the violator to be disqualified.

2. All classes are to be conducted in accordance with the rules of AHA. Judging, class specifications, rules and conduct shall be in accordance with the current USEF/EC Rulebook.


3. In the event of any rule violations which necessitates a disqualification of any entry, Show Management will make the necessary corrections and submit the results to the AHA office.

- a. All decisions made by the Judge(s) and/or Show Management are deemed final and cannot be protested.
- b. Refer to SHOW 118 regarding Warning Card Procedures.
- c. Refer to SHOW 119 regarding removal from competition grounds.

d. Any rule violations and/or judge/exhibitor grievances must be made in writing to the AHA Judges & Steward Commissioner within 10 days following the end of the show. Should the Commissioner find merit, the matter will be sent to the Commissioners Review Panel for further consideration. If a violation is found, the Commissioners Review Panel will act on the matter or it may be forwarded to the Ethical Practice Review Board (EPRB) for a hearing.

e. AHA will honor the Safe Sport requirements and suspensions of USEF.

**DIRECTIONS TO PIMA COUNTY FAIRGROUNDS:** 11300 S Houghton Road, Tucson AZ. Exit Interstate 10 (I-10) at Houghton Road. Drive South on Houghton to Brekke Road. At Brekke Rd turn right. Follow the road until you see the Pima County Fairgrounds entrance on the left and turn in. Follow the road to the covered arena. Show office located on the south side of the arena building.



**INDEMNITY AND NON-RESPONSIBILITY CLAUSE:** All entries are accepted with the understanding that the Southern Arizona Arabian Horse Association, Arabian Horse Association, Pima County Fairgrounds, and all employees and volunteers will not be held responsible for any loss, damage or injury to horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee; but solely at the risk of the Exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him/her, his/her gents or employees, or any animal owned or exhibited by him/her and shall indemnify the Southern Arizona Arabian Horse Association, Arabian Horse Association, Pima County Fairgrounds and personnel and all volunteers and employees against all loss, damages and liability thus occasioned, including but not limited to any and all legal costs, including attorney fees which may be incurred as a result thereof. The submitting of any entry form to the Show Secretary shall constitute an acceptance by each person signing same of the provisions herein set forth.

JUDGES. If, for any reason, the judge fails to attend this show or to perform his/her duties, the Show Committee reserves the right to substitute a judge for the one who is officially designated in the Prize List. It is a violation of USEF Rules to commit any act or making any remarks during the show that are considered offensive and/or made with the intent to influence to cast aspersions on the judging (see USEF Rules). No one shall approach a judge with regard to decision at any time unless they first obtain permission from the Show Committee or Steward, who shall arrange an appointment with the judge at a proper time and place.

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

**LOCATION OF CLASSES:** Show management reserves the right to hold classes or portions of classes on the grounds outside the designated arena(s) or change arena assignments if it is found necessary to do so or to change and modify the schedule of events as necessary to accommodate the entries received.

MEDICAL WASTE: All medical waste (needles, syringes, etc) MUST BE DISCARDED only in special sharps containers located at each barn.

**<u>CLASS SIZE</u>**: Any class with fewer than three entries after close of entries may, at the discretion of the Show Committee, be combined with another class or canceled and the exhibitors in the class(es) will be notified accordingly. Large classes may be divided and conducted as two separate classes with duplicate prizes and awards, with the exception of championship performance classes.

<u>PARKING AND TRAILER AREAS AND RV PARKING</u>: Specific areas have been set aside for parking of horse trailers and vans of exhibitors reserving stalls. The Barn Manager will direct you to these areas when you check in. <u>No parking between the</u> barns or in designated no parking areas will be permitted. <u>Due to FAIRGROUND REGULATIONS</u>, any RVs found using hookups without the RV permit provided displayed in the window of the unit will be assessed another RV fee by the Fairgrounds.

**POST ENTRIES:** A one-time post entry fee of \$50.00 per horse will be assessed to those entries not postmarked by December 30, 2024. Post entries for classes will close at the end of the preceding session. It is the responsibility of each exhibitor to be properly entered in their respective classes.

**<u>REFUNDS</u>**: To encourage early entries, the management agrees to cancel and refund entry fees (minus office fee) on any horse not fit to show providing written notice and a veterinary certificate are given to the Show Secretary by January 5, 2025. (USEF Rule GR12) Consideration for refunds for cancellation of entries after the closing date will be at the discretion of the SAAHA Show Committee. Substitution of horses will be permitted in accordance with USEF GR 911.

**<u>REFUSAL OF ENTRIES</u>**: The show management reserves the right to refuse, accept conditionally, or to cancel any entries of any exhibitor as stated in the current USEF Rulebook.

**<u>RETURNED CHECKS/DECLINED CREDIT CARDS</u>**: All returned checks or declined credit cards or incorrect credit card numbers will be assessed a \$75.00 charge. In addition, interest of 1.5% per month will be assessed on all outstanding account. The exhibitor will have 10 days from the date of the end of the show to pay the debt or be reported to AHA. If funds and penalties are not paid in full, all points and awards earned at the show will be forfeited.

<u>"RODE DID NOT ENTER" (RDNE)</u>: Any entry which shows in a class in which it was not properly entered will be charged the regular class fee plus a \$50.00 RDNE fee. To be properly entered in a class, the class must have been listed on the original entry blank or on a properly submitted Add/Scratch Form in the horse show office. Telling the paddock manager or gate personnel to add an entry to a class does not constitute a proper entry and will result in the RDNE charge. Further, the paddock master or gate personnel are not responsible for keeping an entry out of a class that is not properly entered.

**<u>RV SPACE</u>**: Spaces are available on the show grounds. Contact Julia Casillas at Pima County Fairgrounds at (520) 762-9106 or julia@pimacountyfair.com to make reservations.

**SCHEDULE**: Show Management reserves the right to change the dates and/or the location of the show or to cancel the show altogether. In the event of a cancellation, all entry fees and staff fees will be refunded (office fees are non-refundable). Neither the Show Management nor the Southern Arizona Arabian Horse Association shall have any liability to any exhibitor, owner, handler or other person, firm or corporation by reason of any change or cancellation of the show, except for the return of fees as aforesaid.

**SECURITY**: Exhibitors and vendors are advised that it is their responsibility to secure all their valuables while on the show grounds. SAAHA will not be responsible for lost or stolen items. No security will be provided by the show.

### **SHOW OFFICE HOURS:** Office hours will be:

- Saturday & Sunday:

**STABLING FACLITIES:** Horse stalls & tack/grooming stalls are \$50 per day or any part thereof or \$110 for the show (Jan 10- 12, 2025) and may be limited depending on the number of entries received. **Anyone using a stall will be charged for it; this includes temporarily tying a horse or storing supplies and/or tack.** Stalls will be available at 9:00 am on Friday January 10, 2025 and must be vacated by 12:00 midnight on Sunday January 12, 2025, Each animal must be assigned a separate stall (except brood mares with suckling foals). **Stalls** The 600 permanent stalls are 10ft x 10ft; stalls in the main barn have 2 part doors with metal bar enclosed upper door and solid bottom door; the stalls in the "A" &" B" barns have a chain link upper door and a solid wood bottom door. Stalls in Barn "C" are concrete block and have a solid wood bottom door; they do not have an upper door and will only be used by special request of the exhibitor. Assignment of stalls is entirely at the prerogative of the show management. Assignments will be made as fairly as possible on the basis of many considerations, including the number of horses, time of receipt of entries, overall pattern to optimize use and convenience, show decor, ring use or access. If you have any special requests, please submit them with your entry but once assignments have been made, do not deviate without the <u>specific</u> approval of the Barn Manager. A minimum of at least one bag of shavings must be ordered & used in each stall.

**STALLIONS:** Stallions may be shown by any woman and junior exhibitor in all classes open to stallions. Exception: Stallions are prohibited in Walk/Trot and Leadline classes and are discouraged in Showmanship Classes. Unruly horses in any class will be promptly dismissed.

**VACCINATIONS:** Bring documentation for proof of Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) vaccinations administered within the last 6 months to the show office for verification upon checking. Exception for foals 7 months of age or younger.

**VETERINARIAN:** Veterinarian will be on call during the show. The veterinarian's phone number and other emergency numbers will be posted inside & outside the show office. The Show Committee reserves the right to refuse entry onto the show grounds to any horse exposed to or which may be harboring a communicable disease. All horses may be subject to examination by a veterinarian as per USEF Rulebook.

<u>WALK/TROT/JOG ENTRIES</u>: No rider competing in a Walk/Trot/Jog class can compete in another class which requires the canter/lope. Exception: Short Stirrup Reining.

### AHA ENTRY AGREEMENT

I have read the rules concerning competitions as printed in the Arabian Horse Association<sup>®</sup> (AHA<sup>®</sup>) Handbook and the Value Show Rules and agree to be bound by and subject to those Rules and understand all decisions made by the judge are deemed final and can not be protested.

#### AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION

#### This document waives very important legal rights. Read it carefully before signing.

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, leasee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.

I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

I AGREE for myself, my heirs, executors, administrators, successors and assigns to release AHA, the Competition, the facilities leased by the Competition and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and all claims for damage, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent permitted by law that arises out of or relates in any way to the Competition and my participation in the Competition INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER ENTRANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises.

IAGREE to indemnify and hold harmless (that is pay all losses, damages, attorneys fees and costs of) the Released Parties from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations (including attorneys fees) of whatsoever kind and nature, which may be asserted against or incurred by any of them as a result of (1) my participation in the Competition or (2) any act, failure to act, or neglect (a) by me, my agents, employees, riders, handlers, trainers, coaches, drivers, contractors or invitees, or (b) by any animal owned or exhibited by me or in my custody or control.

I AGREE to accept AS FINAL any decision of AHA, the Show Commission or Show Officials concerning my qualification or the qualification of my horse to enter the Competition or any results of the Competition, except to the extent that the Rules of AHA, the Competition, Equestrian Canada or U.S. Equestrian Federation permit a protest or hearing of such decisions. Should a hearing be requested, I agree to accept AS FINAL the decision of the particular hearing body. I agree to release, hold harmless and not to sue AHA, the Competition Sponsor, their officers, directors, employees, volunteers or members concerning any decision of AHA, the Competition, its Show Commission, Show Officials or any hearing body that relates to my qualifications or my horse(s)' qualifications to enter the Competition or any results of the Competition.

I AGREE that AHA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event, and I agree that AHA may use or assign, in any way AHA sees fit, photographs, films, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition or AHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way which implies endorsement of any company, product, product category or service. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

I AGREE and represent that I am qualified and eligible to enter and/or participate in the Competition and every horse I am entering is qualified and eligible as entered .

#### I FUTHER AGREE that by participating in an Amateur class that I am in compliance with the USEF Amateur rule.

By signing below as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.

This AHA Assumption of Risk, Release and Indemnification is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against AHA, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall remain in effect.
